

Special Drive-2/Spot Round for admission in PG programmes-2024 at SPA Bhopal against vacant seats in Unreserved SC, ST, EWS, OBC-NCL and PwD categories

A Special Drive for admission in PG Programmes at School of Planning and Architecture, Bhopal, will be conducted to fill possible vacant seats in the categories of Unreserved SC, ST, EWS, OBC-NCL and PwD across various PG programmes.

- 1. Applications are invited for the following programmes for vacant seats under category notified in Annexure-1:
 - Master of Planning (Environmental Planning) i.
 - Master of Planning (Transport Planning and Logistic Management) ii.
 - Master of Architecture (Urban Design) iii.
 - iν. Master of Architecture (Landscape) / Master of Landscape Design
 - Master of Architecture (Conservation) / Master of Conservation ٧.
 - Master of Design vi.
- 2. A candidate can apply for a single programme only
- 3. A candidate is required to submit application form online at the given link: https://forms.gle/C27EV1MFUgDZorx5A on or before 15th August 2024
 - a) A candidate shall be required to pay an application fee of INR 2,000/- (Unreserved/ EWS / OBC-NCL) and INR 1,000/- (SC / ST / PWD) through SBI I-Collect link https://www.onlinesbi.sbi/sbicollect/icollecthome.htm?corpID=156579 (Select State Madhya Pradesh, Educational Institutions, School of Planning & Architecture) by 15th August 2024
 - b) Candidates who had earlier applied but not appeared for the PG Direct Admission-2024 / Entrance examination conducted by SPA Bhopal for session 2024-25 and wish to apply for admission through special drive-2 are required to apply again. But they are exempted from paying the application fee.
- 4. Selection of eligible candidates will be on the basis of written test and interview scheduled to be held on 16th August 2024 at SPA Bhopal campus.
- 5. Valid SC / ST / EWS/ OBC-NCL / PwD certificate as per Central Government format along with the required documents and credential are to be compulsorily submitted along with form
- 6. Award of GATE / CEED Scholarship shall be subject to the norms as decided by the Institute

Note:

- 1. The category wise Seat Matrix is subject to availability of vacant seats in the respective programmes at the time of special drive admission (tentative list is also attached for reference).
- 2. If the Institute is unable to offer seat in any of the categories with respect to any of the disciplines mentioned above, the application fee remitted by applicants in that category and discipline will be refunded in full.
- 3. As per the approval of Senate of SPA Bhopal, since this is second notification of PG Admission-2024 admission process, in case any seat lying vacant under EWS Category even after Special drive, any such seat will be considered under Unreserved(UR) category and offered as per merit list.
