- 4 All candidates must bring all your original certificates, marks sheets, testimonials, experience certificates, valid OBC-NCL caste certificate and other relevant documents for document verification. Candidates have to bring and submit a set of photocopies (self attested) of the relevant documents for submission at the time of document verification. Document verification will be done before skill test.
- 5 The Candidates mentioned above should submit proper OBC (NCL) caste certificate during document verification on the day of skill & written test as per the proforma of Govt. of India (which should be valid as on the last date of submission of online application or as per the GOI Rules from time-to-time. The certificate should at least have been issued in the current or preceding Financial Year i.e 2022-23 or 2023-24.
- 6 If the applicants mentioned above are serving in CentralGovt./State Govt./Semi Govt./PSUs/ Govt. Funded Institutions/University/ Autonomous Bodies and not forwarded their application through proper channel, they have to compulsorily submit **No Objection Certificate (NOC)** along with **Vigilance Clearance** from their present employer at the time of document verification.
- 7 Please note that all the candidates whose names are mentioned above are provisionally shortlisted based on the online application, declaration given, information furnished and testimonials submitted by the candidates.
