- 5 Please note that, if the candidates fails to produce documents pertaining to essential qualification & experience, valid category certificate, No Objection Certificate and Vigilance Clearance Certificate (if applicable) during document verification, he/she will not be allowed to attend presentation / interview. **No Undertaking to this effect will be considered.**
- 6 The above candidates are required submit valid OBC-NCL caste certificate during document verification as per the proforma of Govt. of India (which should be valid as on the last date of submission of online application or as per the GOI Rules from time-to-time. The certificate of OBC (NCL) should have been issued in the current or preceding Financial Year i.e. 2023-24 or 2024-25.
