- 2 All the candidates Provisionally Shortlisted are subject to verification of original documents pertaining to essential qualifications, experience and valid category certificate, if applicable, as per prescribed format of Govt. of India.
- 3 The Written Examination of qualifying nature for above mentioned Provisionally Shortlisted candidates is scheduled on 23.02.2025 (Sunday). Call Letter for written examination shall be sent separately to above mentioned candidates.
- 4 There will be separate Written Examination for Architecture & Allied Department and Planning & Allied Departments. The candidates who have applied for the post of Assistant Professor in both the departments have to appear in Written Examination for both departments separately.

Schedule of Written Examination:

Planning & Allied Department : 23.02.2025 (Sunday) from 12:00 PM to 02:00 PM (Reporting Time: 11:00 AM)

Architecture & Allied Department : 23.02.2025 (Sunday) from 02:30 PM to 04:30 PM (Reporting Time: 01:00 PM)

- 5 The Written Examination will be on domain knowledge.

Total marks for the exam will be 100 and duration will be 120 minutes.

1. Two questions (descriptive type) on domain knowledge will be of 50 marks (25 marks of each question)
2. 25 questions will be objective type with MCQ (2 marks for each question)

- 6 The candidates, who will qualify the written examination as per the criteria decided by the Institute authorities, will be eligible for attending the Classroom Teaching Test & Interview. The list of qualified candidates will be uploaded on Institute website on the day of written examination.
- 7 The Document Verification, Classroom Teaching Test & Interview is scheduled on 24.02.2025 (Monday) & 25.02.2025 (Tuesday). Schedule will be communicated to qualified candidates only.
- 8 Please note that, if the candidates fails to produce documents pertaining to essential qualification & experience, valid category certificate, No Objection Certificate and Vigilance Clearance Certificate (if applicable) during document verification, he/she will not be allowed to attend classroom teaching test / interview. **No Undertaking to this effect will be considered.**
- 9 Candidates belonging to SC, ST & OBC (NCL) category should submit valid caste certificate during document verification as per the proforma of Govt. of India (which should be valid as on the last date of submission of online application or as per the GOI Rules from time-to-time. The certificate of OBC (NCL) should have been issued in the current or preceding Financial Year i.e. 2023-24 or 2024-25.

- 10 Please note that the candidates are provisionally shortlisted based on the online application, declaration given, information furnished and testimonials submitted by the candidates. In case, it is found that any of the information/document/testimonials is incomplete, concealed or found false at any stage then the candidature will stand cancelled automatically.
- 11 If the applicants is serving in Central Govt./State Govt./Semi Govt./PSUs/ Govt. Funded Institutions/University/ Autonomous Bodies and not forwarded their application through proper channel, they have to compulsorily submit **No Objection Certificate (NOC)** along with **Vigilance Clearance** from their present employer at the time of document verification.
